| <b>Movement and public gatherings</b> | <b>Ban on mass/social gatherings</b>          | <p>Gathering of population in closed and in open public spaces is banned.</p> <ul style="list-style-type: none"> <li>• Ban on public gatherings, public events, sports, political, cultural-artistic and private gatherings, weddings, as well as other events except for professional, scientific, work and official activities, with the observance of the prescribed measures;</li> <li>• Ban on organizing entertaining and recreational activities for children and adults in open public spaces (entertainment parks, panoramic wheel, etc.).</li> </ul> <p><b>Exception:</b></p> <p>Activities in the area of culture implying simultaneous presence of numerous persons in the same space (theatres, cinemas, museums, galleries) are permitted, with observance of Recommendations for cinemas and Recommendations for cultural events developed by the Public Health Institute of Montenegro, also available on the Webpage: <a href="https://www.ijzcg.me/me/savjeti/covid-19">https://www.ijzcg.me/me/savjeti/covid-19</a></p>  |

The exception refers to persons in charge of taking care of persons who, due to their illness, condition or consequences of injury, are incapable of independently performing daily life activities. If these persons are mutually related, it is necessary to have the <b>certificate issued by the chosen doctor</b> for a person who needs care and the <b>excerpt from a relevant registry of citizens</b>. If these persons are not mutually related it is necessary to have the <b>Contract of Care or Contract on Supporting People Who Need Care</b>. Their mutual kinship or legal relationship can be established on the basis of these documents.</li> </ul>  |

|                                       | <b>Ban on visits</b>  | <ul style="list-style-type: none"> <li>• Ban on visiting people undergoing hospital treatment in health institutions and persons accommodated in institutions of social and child protection;</li> <li>• Ban on visiting detainees and persons serving the imprisonment sentence in the Administration for execution of criminal sanctions, except for lawyers and court experts as per the court decision, and close family members with observance of recommendations of the Institute</li> </ul>  |

It is mandatory to observe the measures related to proper wearing of the face masks and keeping the two meters distance. It is banned to linger for more than 30 minutes.</li> <li>• Religious communities shall appoint <b>one or more persons to control</b> the performance of religious ceremonies. Namely, these persons will control if persons entering or staying inside the religious facilities are wearing the face masks and observing the minimum physical distance.</li> <li>• Hand disinfectants are to be provided at the entrance/exit from the religious facilities and clearly place the notification on the number of persons allowed to be in a religious facility at the same time. Notifications on the proper wearing of the face masks, with necessary physical distance of minimum 2m should be placed as well.</li> <li>• It is <b>forbidden to touch and have any physical contact with any of the common use objects.</b></li> <li>• Religious communities shall, whenever possible, broadcast their ceremonies via radio or TV programme, or otherwise, which will enable the believers to attend the religious activities without going to the religious facilities.</li> </ul> |
